General Private Practice:

This practice focuses primarily on direct psychological services to children and families and consultation with agencies serving children. It also includes consultative services.

Consultative services currently include:

Special Education Divisions of multiple school districts in the West Texas area. These services include evaluation of students for eligibility for service as emotionally disturbed. Additionally, I head up a team comprised of educational diagnosticians and speech pathologists that provide specialized evaluation of developmental disorders including Learning Disabilities and Pervasive Developmental Disorders. Individual and family therapy, crisis management, staff consultation, and continuing education are also provided.

- Other services which have been provided during my time in individual private practice include workshops on professional ethics periodically offered to human service professionals in the area, consultation with Concho Valley Home for Girls, Tom Green County Probation Department, Family Outreach Services, Department of Human Services, West Texas Boys Ranch, and community education programs offered through St. John's Hospital Health School.
- I also work with physicians in the San Angelo area consulting with patients who are suffering from a variety of physical conditions exacerbated by psychological stressors. These conditions include cardiovascular disorders, chronic pain, hemodialysis, and substance abuse.
- I also consult with the District Courts on child custody litigation, parental rights determination, and as an expert witness on child and adult sexual abuse and assault.
- I provide professional supervision to clinicians in the community seeking licensure in the mental health field.
- I serve on the Texas State Board of Examiners of Psychologist to evaluate prospective psychologists.

Other Professional Experience:

- Half time Clinical Faculty, Angelo State University; This position includes instruction of graduate and undergraduate classes in the Department of Psychology. Additionally serving as supervisor of practicums.
- Assistant Professor, Angelo State University; August 1987 August 1993. This position included instruction of undergraduate and graduate classes in the Department of Psychology as well as supervision of interns and guiding research of students in the Graduate Program. Graduate programs developed and taught include Psychopathology, Ethics and legal Issues in Human Services, Theories of Counseling, Theories of Personality Development, Health Psychology, and Behavior Therapy.

Chief, Mental Health Clinic, Goodfellow Air Force Base, Texas; August 1981 – August 1984. This position was responsible for the administration of the Mental Health Clinic as well as provision and supervision of psychological services. The full range of clinical services was provided to include treatment of individuals involved in child neglect and abuse. Specialized programs established included an outpatient pain and stress management clinic and a drug testing and rehabilitation program.

While at Goodfellow Air Force Base, there was also involvement in several volunteer projects in the civilian community.
