## Option 1 - All tests approved, enrolled and completers

- (1) for the most recent year for which the information is available, the results of the first two attempts on all certification examinations prescribed under Section 21.048(a) that are approved by an educator preparation program and taken by a person who:
- (A) is enrolled in the educator preparation program; or
- (B) has completed the educator preparation program within three years before the date the examination is taken;

# Option 2 - All tests approved for initial certification, enrolled and completers

- (1) for the most recent year for which the information is available, the results of the first two attempts on all certification examinations prescribed under Section 21.048(a) that lead to an initial certification in each class of certificate that are approved by an educator preparation program and taken by a person who:
- (A) is enrolled in the educator preparation program; or
- (B) has completed the educator preparation program within three years before the date the examination is taken;

# Option 3 - All tests approved for initial certification, completers

(1) for the most recent year for which the information is available, the results of the first two attempts on all certification examinations prescribed under Section 21.048(a) that lead to an initial certification in each class of certificate that are approved by an educator preparation program and taken by a person who has completed the educator preparation program within three years before the date the examination is taken;

### Suggestion for Change to Small Group Exception

Apply small group exception of Aggregated Group to Disaggregated Groups and Certification Field Aggregated and Disaggregated groups

- If less than 20 in year one, does not count
- If less than 20 in year two and sum of year one and two are less than 20, does not count
- The three-year cumulated group performance must be measured against the standards in that third year, regardless of how small the cumulated number of group members may be
