2. Impact of change:

Residential Programs: None. Students can complete housing renewal applications online as soon as the Web Application goes live on 2/1/08. We have learned that the Housing software actually functions in two separate parts... application and assignment. The proposed dates are in keeping with what our process has been, and keeps the current internal timeline, but recognizes that the two functions (application / assignment) are separate, requiring different actions on the part of the student and housing staff. Our internal renewal process timeline is unaffected.

Information Technology: Extension of the project milestone date for the My Housing web module go-live will allow ASU Information Technology members of the Adirondack Implementation team more time to work on the authentication issue that was found this passed week. However, the person who will have to dedicate his time to this issue is also the person who is reworking the required registration information web page for the ASUAlert project. As this resource is shifting his focus to resolve the authentication issue, backup plans are being made to get students to review their ASUAlert information through the required registration process for the upcoming April registration period instead of forcing them to review their ASUAlert information during the registration process.

The authentication issue came to light as the implementation team began testing their web housing application processes. As they begin testing the My Housing module we
