E. Discussion of Minors

1. Concern over losing a program if the upper level courses aren't supported by students taking them for minor

2. P328 in catalog, multi-area minor - A set of courses selected from two or three academic disciplines. Nine semester hours, including at least six advanced semester hours in residence, are required in each component discipline of a multiple area minor. Certain multiple-discipline minors which have been department-tally designed are not required to meet these general requirements for the multiple area minor.

3. DT – concern over Minors being an obstacle to graduation for transfers

4. DT - Current proposal is from College of Science and Engineering – allows departments/programs to require minor on their specific degrees

5. DT - 1968 – president of ASU mandated required minors

6. What rationale would be required of a department wanting a required minor?

a) Need and minors should be assessed similar to assessment of majors

7. Language of "prescribed electives" – some majors have so many of these that the minor becomes automatic (e.g. Physics with 21 hours of Math courses)
