Angelo State University CARES Act Student Aid Report #1 (5/9/2020)

PR/Award No. P425E200004

Introduction

On March 27, 2020, the President of the United States signed the CARES Act (H.R. 748), which provides emergency relief funds to organizations and individuals affected by the coronavirus pandemic. The Higher Education Emergency Relief Fund (HEERF), found in Section 18004 of the CARES Act, provides funding to institutions of higher education "to prevent, prepare for, and respond to coronavirus." This report provides details on the first award Angelo State University (ASU) received under the HEERF, the funds for Emergency Financial Aid Grants to students.

Acknowledgement of Funding and Certification

ASU reviewed, signed, and returned the <u>U.S. Department of Education's Certification and</u> <u>Agreement</u> for these funds on April 10, 2020, and we received our grant award notification on April 17, 2020. In keeping with the terms of the certification, ASU will use no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants directly to students.

Total Award

ASU will receive a total of \$6,359,561 under Section 18004(a)(1) of the HEERF, of which at least **\$3,179,781** will be provided directly to students impacted by campus disruptions due to the novel coronavirus.

Funds Distributed to Date

As of the close of business on May 8, 2020—just two weeks after inviting students to request the funds—ASU has awarded **\$2,414,224** in direct grants to students.

Student Eligibility

The total number of ASU students eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and therefore eligible to receive CARES Act emergency financial aid grants is **5,319¹**. Of those students, **1,944** have received an award as of May 8, 2020.

Methods Used to Determine Which Students Receive Aid and How Much

ASU created an online grant application in which each student indicated: 1) whether they had been impacted financially by the coronavirus, and 2) what specific financial needs they have in

each area (food, housing, technology, course materials, health/child care, and other costs). The Financial Aid office evaluated each application based on the information provided, and they awarded funds based on each student's identified needs and the availability of funding. If students failed to provide sufficient documentation regarding their needs, the Financial Aid office contacted them to obtain additional information before issuing an award.

Provided that the students were eligible to receive funds and identified legitimate needs, grants of up to \$1,500 were automatically approved. To ensure the availability of funds for as many needy students as possible, mid-level managers and senior administrators reviewed requests exceeding \$1,500 to determine the necessity for and feasibility of providing larger awards.

Instructions or Directions Given to the Students

In accordance with the Secretary of Education's instructions for institutions to issue aid to students as soon as possible under the student aid portion of the CARES Act HEERF, Interim President Angie Wright sent ASU students, faculty, and staff advance notice of the program on Monday, April 20.

Thereafter, ASU's Office of Communications and Marketing sent an email message to all students, regardless of their eligibility, to inform them of the availability of funds under the CARES Act on April 23, 2020. ASU also communicated the same information via its newly created CARES Act webpage and as an announcement in RamPort, ASU's student information portal. Staff emailed additional notices to students through the beginning of May to ensure they had multiple reminders of and opportunities to request financial support.

These communications contained the following information:

- General instructions on the purpose and allowable uses of funds,
- Application periods,
- A link to the online application,
- Contact information for questions, and
- Acknowledgement of the federal government as the source of funding.

Copies of the following instructional/informational materials given to the students include the following, which are attached to this report in the order listed:

- 1. Email announcement of funds and application soon to be available dated April 20, 2020
- 2. Email notification: Availability of funds and link to application dated April 23, 2020
- 3. Screen shots of the full application for funds, including instructions, students were required to complete to access the funds
- 4. ASU's CARES Act Informational/Instructional webpage

Dear Ram Fam,

I hope this finds you safe and well.

As you may have heard, Angelo State University has received federal funding from the CARES (Coronavirus Aid, Relief, and Economic Security) Act. This is good news in a time that your lives have been disrupted in so many ways.

A large portion of the CARES Act funding is intended to provide emergency aid to students for food, housing, course materials, technology, health care and childcare – needs that may be difficult to meet while continuing studies in this environment or due to other mitigating circumstances such as loss of employment due to the pandemic.

We are working quickly to get this emergency funding to currently enrolled students to help with the rest of the spring semester - April and May. We are currently preparing a simple grant application that we will email students.

Funding will be distributed based on the completion of this grant application. Our goal is to get these emails out as soon as possible.

Students, please check your Angelo State email account regularly. Once you receive the email with this application, make sure you answer the questions accurately and completely and then submit the application. We won't know that you need funds unless you submit the form.

We are pleased that our federal legislators understand what so many of you are going through and made these grants possible. They do not require repayment. We hope this helps relieve some of the stress and financial burden during uncertain times.

CARES Act [web page]

ASU has received federal funding from the <u>CARES Act</u>, which provides assistance for student expenses related to the disruption of campus operations due to coronavirus. Students can request funds in these categories:

- Food
- Housing
- Course Materials
- Technology
- Health Care
- Childcare expenses
- Other Expenses (Expenses that do not fit any of the above)

Am I eligible?

You may be eligible for CARES Act funding if you are a degree-seeking student enrolled in at least one face-to-face course during the 2020 spring semester.

International, dual credit, non-U.S.-citizen, non-degree-seeking students, and students enrolled exclusively in online courses prior to March 13, 2020 are not eligible for CARES Act funding.

How do I apply?

The 2020 spring semester CARES Act grant application is now closed. The grant application for expenses related to the 2020 **Summer I** semester will be available beginning on **May 15**. The grant application for expenses related to the 2020 **Summer II** semester will be available beginning on **June 29**.

FAQs

• What is the CARES Act?

The <u>Coronavirus Aid, Relief, and Economic Security (CARES) Act</u> is federal legislation that provides a variety of financial support to individuals and organizations affected by the COVID-19 (novel coronavirus) pandemic.

The CARES Act includes a Higher Education Emergency Relief Fund (HEERF) that provides more than \$14 billion in emergency funding to higher education. Of those funds, more than \$6 billion must go directly to students in the form of emergency financial aid grants (HEERF-student share) for expenses related to the disruption of campus operations due to the COVID-19 crisis. Angelo State University will receive a total of \$6,359,561 of which at least half (\$3,179,781) must be provided directly to students for their expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child-care. The other half may be used by the university to cover costs associated with significant changes to the delivery of instruction due to the coronavirus.

• How much will I receive?

We are committed to assisting all eligible students that may have been impacted by the coronavirus pandemic to the greatest extent possible with the CARES Act funds available. You should request funds based on your actual financial need for expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child-care, for the time period of the emergency. The actual amount each student will receive is based on the number of applications received and the funds available.

The amount that you were approved for can be found in RamPort. Select Financial Aid & Billing, then "View Bill", and submit 2020 Spring Semester. The amount will display as CARES Act Refund.

• How will I receive this money?

Emergency grants will be processed through student accounts.

If you have an ASU One Card, you will receive your funds via Bank Mobile. You can monitor the status by visiting <u>www.ASUOne.com</u>.

If you do not have an ASU One Card, you will receive an email notifying you of when your funds are available from the Student Accounts office.

• Do I need to repay the money?

No, you will not need to repay any money received through this fund.

• Can I apply for funding more than once?

If you received CARES funding in the spring, you are still eligible to apply in the summer. New grant applications can be submitted in May and June for expenses related to Summer I and II.

• Does this funding affect my other financial aid?

No. This is an emergency grant to help you manage unexpected expenses related to the coronavirus, and it will not have any impact on other financial aid you may be eligible to receive.

• What if I still have an account balance?

Any CARES Act funding awarded to you will be paid to you directly, and it will not cover any outstanding balances owed to Angelo State. Any outstanding balance owed to ASU will remain the responsibility of the student.

• Are the Emergency Grants taxable?

It is unclear at the moment. If we receive updated guidance from the U.S. Treasury Department, we will add that here.
