

Articulation Agreement between Angelo State University and



McLennan Community College

This Articulation Agreement is made and entered by and between McLennan Community College hereinafter called "MCC" and Angelo State University, an institution of higher education of the State of Texas and a member of the Texas Tech University system, hereinafter called "ASU".

Whereas ASU is dedicated to service the educational needs of the citizens of the state of Texas as a part of its mission statement, and

Whereas MCC is dedicated to fulfilling its mandate to serve the educational needs of the citizens of its service area, and

Whereas ASU and MCC are supportive of cooperative attempts to meet these educational needs, and

Whereas ASU and MCC enter into this agreement in order to offer cooperatively a greater range of educational opportunities to the citizens of the state of Texas.

Therefore, and in consideration of the foregoing and in further consideration of the mutual benefits, the Parties hereto agree as follows:

ARTICLE I TRANSFER AGREEMENT AND TRANSFERABILITY OF COURSES

A student transferring to any of the current programs at ASU under this agreement shall have full acceptance of academic credits earned at MCC. The department chair of social work determines how these credits may apply to the degree plan to ensure all requirements for graduation from ASU are met for the student's program of study.

Transfer into any social work program within the Department of Social Work and Sociology will be subject to the following regular ASU admission provisions:

- 1. The student will have graduated from MCC with an associate's degree, or
- 2. The student will have earned a minimum of twelve academic semester credit hours with a cumulative grade point average of at least 2.0 on a 4.0 scale.

Courses listed in the Texas Common Course Numbering System Guide will transfer to ASU as indicated in the guide. Other MCC academic courses will transfer as non-equivalent work unless they are validated as substitutes for specific ASU courses by mutual agreement between appropriate ASU and MCC personnel.

Course Transferability

A student transferring to the Social Work or Sociology program at ASU under this MOU shall have full acceptance of academic credits earned at MCC. Students should reference the Appendix A for information on how courses will transfer for their respective academic program. ASU will accept up to 15hrs of WECM credit from MCC in the following course rubrics: CMSW, DAAC, GERS, PMHS, PSYT, SCWK.

Reverse Transfer

Reverse transfer is the process of awarding an associate's degree to students who begin their education at one institution, transfer to another institution, and complete their associate's degree requirements while working toward a bachelor's degree. ASU and MCC will develop a reverse transfer process to provide students with the opportunity to complete the associate's degree while working on their ASU bachelor's degree. Student records will be exchanged between ASU and MCC for this purpose, strictly adhering to all privacy regulations and ensuring compliance with House Bill 3025.

Scholarships

MCC students are encouraged to complete their application for admission to the university and submit official transcripts as early as possible to be considered for ASU Distinguished Transfer Scholarships. As long as funds are available, scholarship amounts are based on the number of transferable hours and grade point average earned and are renewable based on award criteria.

ARTICLE II RESPONSIBILITIES OF THE PARTIES

ASU agrees to:

- 1. Visit all MCC campuses at least once a semester during the fall and spring semesters with additional opportunities as schedules and availability allow.
- 2. Maintain course equivalency tables on the ASU admissions website.
- 3. Develop and maintain transfer guides for fields taught at both institutions.
- 4. Coordinate meetings with faculty and administrators to discuss course equivalency, program changes, and support of students transferring to ASU.
- 5. When requested by a student, provide initial transcript evaluations for prospective transfer students prior to applying to ASU.
- 6. Provide academic advising assistance to prospective transfer students prior to admission to the university.
- 7. Educate appropriate faculty and staff regarding course equivalency and transfer guides.
- 8. Include the MCC logo and articulation agreement on the ASU website.
- 9. Provide student records to MCC for the purpose of reverse transfer, strictly adhering to all privacy regulations and ensuring compliance with House Bill 3025.

MCC agrees to:

- 1. Schedule MCC campus visits with ASU admissions counselors upon request. Contact Advising and Career Services to make arrangements.
- 2. Notify ASU Office of Admissions regarding changes in course inventory offered at the institution that may affect the course equivalency tables.
- 3. Distribute ASU transfer guides and display the marketing materials provided by ASU.
- 4. Participate in meetings with faculty and administrators to discuss course equivalency, program changes and support of students transferring to ASU.
- 5. Promote the availability of initial transcript evaluations for prospective transfer students prior to applying for admission.
- 6. Promote the availability of academic advising assistance to prospective transfer students prior to admission to the university.
- 7. Educate appropriate faculty and staff regarding course equivalency and transfer guides.

ARTICLE III SEVERABILITY

If any term or provision of this agreement is held to be invalid for any reason, the invalidity of that section shall not affect the validity of any other section of this agreement provided that any invalid provision is not material to the overall purpose and operations of this agreement. The remaining provisions of this agreement shall continue in full force and effect and shall in no way be affected, impaired, or invalidated.

ARTICLE IV AMENDMENT

This agreement may be amended in writing to include any provisions that are agreed to by the contracting parties.

ARTICLE V VENUE

This agreement shall be governed by and construed and enforced in accordance with the laws of the State of Texas. Venue will be in accordance with the Texas Civil Practice & Remedies Code and any amendments thereto.

ARTICLE VI ASSIGNMENT

Neither party shall have the right to assign or transfer its rights to any third parties under this agreement without the prior written consent of the other party.

ARTICLE VII INDEPENDENT CONTRACTOR STATUS

Nothing in this agreement is intended nor shall be construed to create an employer/employee relationship between contracting parties. The sole interest and responsibility of the parties is to ensure that the services covered by this agreement shall be performed and rendered in a competent, efficient, and satisfactory manner.

ARTICLE VIII ORIGINAL TERM, RENEWAL, AND TERMINATION

This MOU becomes effective upon the date of the last approving signature and will remain in effect for one year. Thereafter, this MOU shall automatically renew on an annual basis for up to four years unless thirty (30) days written notice of intent to terminate the MOU is given by either party.
