

Article I - The Election Commission

A. The Commissioner

- 1. The Election Commissioner shall be a member of the Senate who is nominated and confirmed by a quorum of the Senate. This person shall also be the chair of the Election Commission. The Commissioner will have final say over the Election Commission and all its actions during the course of the election.
- 2. The Election Commissioner shall assume duties at the last meeting of the fall semester.

B. The Commission

- 1. The Election Commission shall be composed of
 - a. The Election Commissioner
 - b. Two students who are non-members of Student Government that the Student Body President shall appoint (unless he/she is seeking reelection in which case the Election Commissioner shall appoint these students)
 - c. Three Student Senators not running for election appointed by the Student Body President (unless he/she is seeking reelection in which case the Election Commissioner shall appoint these students)
 - d. The Student Body Vice President (unless he/she is seeking reelection, in which case this seat can be appointed at the discretion of the Election Commissioner).
- 2. All student members of the Election Commission must be approved by the Election Commissioner and two-thirds vote of the Student Senate. If a member of the Election Commission fails approval by the Election Commissioner or the Senate, then that person shall not be a part of the Election Commission and their spot must be filled by a representative the Election Commissioner and Senate both agree on. The acting Student Body President shall recommend replacement members and initiate the approval process.
 - a. Student members of the Election Commission shall be in good academic and disciplinary standing and currently enrolled in the University.
- 3. Election Commission members shall take this oath before the Student Senate upon the assumption of their duties, "I____ will execute the duties of Election Commission member to the best of my ability, uphold the Angelo State University Student Constitution and Election Codes, and execute all functions of this office with impartial treatment to ensure a fair and balanced election process."
- 4. The Election Commission serves to offer advice to the Election Commissioner and assist in election related duties as requested by the Election Commissioner.
- 5. The Election Commission shall help promote and monitor the election through posting material (online and on campus) and hosting election events (debates, speeches, etc.) in an impartial manner. The Election Commissioner shall hold Election Commission members accountable for their conduct during the election process.
- 6. Election Commission members may be removed for the following reasons:
 - a. Dereliction of duties and responsibilities
 - b. Candidate bias
- 7. No member of the Election Commission shall show any partiality towards any candidates. Partiality includes, but is not limited to:
 - a. Assisting in posting or distributing any campaign material (online or on campus)
 - b. Wearing campaign material
 - c. Sending voting information that is biased towards one ticket in any capacity (through email, print, or social media)
 - d. Encouraging students to vote biased towards one ticket over another
 - e. Criticizing any candidate that could be overheard by another student and influence that students decision as to who to vote for.
 - f. If any member of the Election Commission is accused of partiality, that member shall immediately



be suspended by the Election Commissioner, who shall then investigate the matter. If the Election Commissioner decides that member acted with partiality, the member shall be removed from the Election Commission. If any member be removed, that seat shall remain vacant for the duration of the election.

- 8. The Election Commission shall appoint a secretary responsible for recording the minutes of meetings and hearings, and keeping a record of all opinions, rulings and filings of candidates under this code.
- 9. The Election Commission shall be confirmed at the last Senate meeting of the fall semester or no later than the first general senate meeting of the spring semester. The Election commission will serve until the next swearing in of the next SGA administration.

C. Authority of the Election Commission

- 1. The rules concerning election procedures must be obeyed and will be enforced by the Election Commission.
- 2. The Election Commission shall settle all disputes that arise during the election and its decision shall be final.
- 3. The Election Commission shall ensure a fair and balanced election process.
- 4. The Election Commission shall enforce all Student Government election rules, Student Government Code of Laws, and university policies.
- 5. The Election Commission has the power to remove or order the removal of any poster or sign that is in violation of the Election Code or Election Commission rulings. The candidate shall be informed of such removal within one (1) school day.
- 6. The Election Commission will comply with all requirements stated in the SGA Code of Laws. In the event that a situation arises which has not been explicitly provided for in the Code or in this Election Code, the Election Commission will determine its validity and enforce any decision the Commission might make in acting upon such a situation.
- 7. The Election Commission may promulgate rules and regulations to the extent that they are necessary in providing an equal opportunity to all candidates during the whole election process.
- 8. The Election Commission may issue a Cease and Desist Order pertaining to distribution of any materials if it believes that the materials contain false information, are misleading in part or in whole, or are in violation of the code or commission rulings.
- 9. The Election Commission shall brief the Senate as necessary about election progress, or upon request from the Senate.
- 10. The Election Commission shall canvas the election results.
- 11. The Election Commission shall confirm election results and proclaim the election results official.

D. Removal of an Election Commission Member

- 1. In the event that a member of the Commission is charged with dereliction of duty or partiality by a written petition to the Election Commissioner and the Student Body President (unless he/she is running for reelection):
 - a. The Election Commission member shall be immediately suspended from Election Commission duties.
 - b. If necessary, the Election Commissioner, with the advice of the Student Body President (unless he/she is running for reelection), shall appoint a student to the Election Commission to assist with election duties.
 - c. A special committee will be comprised of five (5) students to review the petition and the special committee shall have three (3) university business days to review the case against the Election Commission member. The special committee shall be composed of two (2) SGA members not on the Election Commission, 2 (2) non-SGA students not on the Election Commission, and the Student Body Vice President (unless he/she is running for reelection in which case the Student Body President shall fill that role unless he/she is running for reelection.) Otherwise, the special committee position will be offered to the remaining Executive Committee in the order of the



President Pro-Tempore, the Senate Parliamentarian, or the Senate Clerk. If none of the Executive Committee members meet the criteria, the special committee position shall remain vacant.

- d. The special committee shall then present their decision to the Election Commissioner about the Election Commission member charged with misconduct.
- e. The Election Commissioner shall use the special committee's decision as a guide but shall make the final decision regarding the Election Commission member's alleged misconduct.
- 2. If the Election Commissioner is accused with mishandling of the election process, partial treatment of candidates or misconduct unbecoming of the Election Commissioner, then a petition signed by two-thirds of the Student Senate shall be presented to the Executive Director of Student Affairs.
 - a. The Executive Director of Student Affairs shall then hold a meeting with the Election Commissioner to discuss the petition. If he/she decides the complaint is unfounded after that meeting he/she shall send a formal letter to the Student Senate dismissing the petition.
 - b. If the Executive Director of Student Affairs decides the accusation has merit then he/she shall have the Election Commissioner resign as the Election Commissioner for the current election and then notify the Student Government Faculty Advisor.
- 3. In the event that the Election Commissioner is removed from office, then the Executive Director of Student Affairs shall offer the position to the SGA faculty advisor or become the new Election Commissioner

Article II - Filing

A. The process of filing shall be conducted in the Student Life office.

- 1. Filing for the Spring General Election shall begin on the first day of class in February at 8:00 a.m. and end at 5:00 p.m. on the first day of class in March.
- 2. No candidate shall register for any office with the premeditated intention of leaving office before the end of his or her term.
- 3. Upon completion of filing for the Spring General Election, the Election Commissioner shall require all candidates attend a mandatory pre-election meeting within 5 university business day after filing closes to be briefed on the election process. If a candidate misses for an excused absence according to University policy, then the candidate and Election Commissioner shall set a new date to meet within 3 university business days. The Election Commissioner shall use the meeting time to review and elicit discussion relative to the Election Code, expectations of the candidates, and all applicable university policies.
 - a. All candidates shall sign a statement indicating they understand and agree to abide by the Election Code, expectations, and all applicable university policies. Once this and all other required paperwork is completed, official campaigning may begin.
- 4. To be considered an official candidate for an SGA office, the filer must meet all of the following requirements:
 - a. Be certified through the Student Life office.
 - b. Be in good disciplinary standing with the university as defined by the university handbook.
 - 1. If a candidate is not in disciplinary good standing after filing for office and before being sworn in, then that entire ticket shall be removed from the race.
 - c. A President/ Vice-President ticket must remain whole for the entire duration of the election process.

Should either member of the running ticket choose to withdraw from the election at any time after filing, the running ticket will be disqualified for the rest of the election process.

d. Both members of the President/Vice- President ticket must have served as members of Student Government for a minimum of one year prior to running. A year shall refer to the completion of one semester of SGA and the participation of the following semester in such that a senator who joins in the Fall semester may run in the spring so long as they meet other outlined criteria regarding good standing. Should the ticket seek an exemption, an exemption form must be filed. **See attached exemption request**.



- e. Both members of a running ticket shall be in good standing with the Angelo State Student Government Association. Any previous impeachments, absence removal, or failure to work with the Director of Student Life shall disqualify each member as a candidate for either President or Vice-Presidential position. Should the ticket seek an exemption, an exemption request must be filed. **See attached exemption request.**
- f. Sign a release form which states the candidate has read and understood the rules and regulations of the SGA Election Code. **See attached release form**
- g. Meet all GPA and enrollment requirements as outlined in the SGA Constitution and By-Laws.
 - 1. A candidate shall sign a grade release statement enabling the Commission to check grade qualifications of the candidates. **See attached exemption request**
- h. Submit a written campaign strategy to Election Commission prior to campaigning (a candidate may submit a strategy as soon as they file).
- i. Hold office hours throughout the entire summer prior to assuming office for presidential and vice presidential candidates, if possible.
- 5. An exemption request must be completed by the candidate and filed with Student Life and Student Government Association if a candidate is unable to meet one of the criteria prior to being certified as a candidate. **See attached exemption request**
- 6. No person shall file for more than one position in the Student Government Association.
- 7. A presidential or vice-presidential candidate must choose a running mate prior to elections. Running mates will be placed on the same ticket.
- 8. A candidate may change the office they are seeking during the period of filing.
- 9. In the case that either candidate for Student Body President or Vice President resigns from the campaign due to extenuating circumstances, the remaining candidate for Student Body President or Vice President will have no later than three (3) days (72-hours) prior to the first Election Day to find a new running mate and present the new candidate to Election Commission.
 - a. Extenuating circumstances include:
 - 1. Death
 - 2. Severe Illness (Family or Self)
 - 3. Leaving the University
 - b. To prove Extenuating circumstance the candidate who dropped from the ticket involved must meet with SGA Election Committee and SGA advisor to provide documentation and/or information for the candidate stepping down from his/her ticket.
 - c. The discretionary power still resides within the Election Committee and SGA Advisor for final determination of any other circumstance that may arise.

Article III - Publicity Rules, Campaigning, and Election Week

A. Publicity Materials

- 1. A candidate must comply with the posting rules as directed by the Election Commission before posting publicity materials on the ASU campus and gain approval of the appropriate authorized Election Commission official before posting any campaign material on campus.
 - a. Posting is defined as, but not limited to, displaying of campaign placards, banners, sandwich boards, flyers, promotional buttons/ribbons, and any electronic medium including social media, websites, emails, or videos.
- 2. A campaign must seek approval of all online publicity (posters, memes, promotional videos, etc.) by the Election Commission prior to posting. A campaign does not need approval to post election updates (days of voting, general tweets to remind students to vote with mention of candidate names, updates about what candidates are doing like attending ASU games etc.). Any questionable material that falls into election



updates shall be reviewed by the Election Commission and appropriate consequences shall be rendered.

- 3. All publicity, online or otherwise, must be honorable and respectful to other candidates and Angelo State University. Any inappropriate content posted online by candidates or supporters of any candidates shall be removed or reported to the Election Commission.
- 4. All posted publicity materials must comply with university posting rules and regulations and on approved university locations. Any material posted in an unapproved location shall be removed by an appropriate Election official or designee.
- 5. Each candidate shall be responsible for the removal and disposal of all campaign material bearing his/her name. Failure to comply with this provision will result in:
 - a. Payment for clean-up as determined by the Election Commission.
- 6. Vandalism to campaign material is not permitted, and perpetrators shall face due consequences if discovered.
 - a. It shall be a direct violation of this Code for anyone other than the Commission to willfully destroy, deface, move, or remove posters of any candidate. The Commission shall perform such only when such campaign materials are found in violation of this Code and after an initial warning is presented to the responsible parties.
- 7. Campaign efforts are to be limited to the Angelo State University campus. Posting of publicity at off campus locations is prohibited.
- 8. Failure or refusal to comply with any provisions listed in this section shall be deemed a violation and action from the Election Commissioner shall result.

B. Campaigning

- 1. Every candidate for any elected position is responsible for knowing and obeying all campaign procedures. Failure to comply with these regulations shall subject the candidate to disqualification.
- 2. Candidates shall refrain from knowingly deceptive or misleading campaign activities, including any act or statement reasonably calculated to injure or compromise the rights or interests of any student, faculty or administrator.
- 3. Candidates shall submit their campaign strategy to the Commissioner for approval and any additional plans must be approved at the Election Training held by the Commissioner or Commission representative prior to campaigning. **See attached form.**
- 4. No campaign material shall be placed in the ASU library (with exception to the third [3rd] floor) or Caf.
- 5. No campaign materials may be posted in the university computer labs and campaign materials may not be attached to any university computer or computer desk.
- 6. Campaigning in the residence halls is prohibited other than providing approved publicity to the Director of Housing and Residential Programs who will work with professional and student staff to display in appropriate locations.
 - a. For example, a candidate, agent or worker may not solicit votes by going door-to-door on campus. This includes but is not limited to, passing out of materials.
 - b. Campaign materials provided to the Director of Housing and Residential Programs for distribution may be no larger than 11x17"
- 7. Candidates are responsible for the actions and conduct of individuals knowingly associated with a candidate's campaign.
- 8. No candidate or organization may utilize any facilities, equipment, and/or services that receive university funding and are not available to the general student body for the purposes of campaigning.
- 9. In conjunction with the Student Code of Conduct, spamming is not allowed under any circumstances.
- 10. The use of paints, whitewash, ink chalk or similar material on any University property is prohibited. No holes may be dug on campus.
- 11. No bands or public address systems that disrupt university activities/functions shall be allowed.
- 12. The use of sound trucks, PA systems, or similar sound systems is prohibited both on and off campus.
- 13. Rallies or other forms of demonstrations must be approved through the Business Services department with



appropriate reservations confirmed to avoid conflicting times of rallies.

C. Election Week

- 1. The Election Commission shall organize activities that may include a speech by the candidates with their vision for the University, a town hall meet and greet, and debates. A faculty or staff member shall moderate the events. Appropriate questions shall be given to the moderator from the Election Commission. **See attached moderator questions**
- 2. All candidates for president and vice president of the student body shall comply with the Election Code and participate in sponsored election activities.

Article IV - Campaign Finance

A. Limitations

- 1. Each candidate is required to finance their respective campaigns.
- 2. In the course of a contested President/Vice President election, SGA will allot no more than \$500 to the Election Commission for the promotion of the elections. This money will be used for unbiased publications, debates, or other activities.

B. Regulations

- 1. No businesses or individuals shall be solicited for campaign donations.
- 2. No additional university funds beyond that allocated from the Election Commission may be used for campaigns or issues involved with the campaign; this does not include student wages paid on behalf of Angelo State University.

Article V - Election Process

A. Elections

- 1. The General Election in the spring semester will be held on two consecutive days beginning on the second Tuesday of April. Any Fall Special Elections will be held on two consecutive days beginning on the second Tuesday following the close of the filing period.
- 2. Special Elections for referendums or amendments may be approved by a two- thirds vote of the Student Senate.
- 3. All elections shall be conducted in online polls. The online voting will take place in a manner which will make best use of current technologies and software available to Angelo State University. The method by which voting will be carried out is to be determined by the Election Commissioner after counsel with a representative from the Department of Information Technology.
 - a. The Election Commissioner shall review the results of the election and verify them with the Department of Information Technology before announcing results.
 - b. The Election Commissioner shall have up to twenty-four (24) hours to announce the election results after voting has ended.
 - c. The entire Election Commission shall canvas the election results, verify the results are correct, and proclaim election results to be official within seventy-two (72) hours after the voting has ended.
- 4. The Election Commissioner, in conjunction with the Department of Information Technology, shall create a ballot that has all qualified candidates listed in alphabetical order of last name indicated in the ASU database. For presidential/vice presidential tickets, the names will be listed based upon the presidential candidate. There must be a space for students to cast votes for senatorial write-in candidate on the ballot.
 - a. If any candidate utilizes a nickname for their first name rather than what is listed in the ASU



database, that name may be included in parenthesis, provided it is appropriate.

- 5. The Election Commission shall not establish a voting booth or official areas of voting.
- 6. No candidate may set up a voting booth or areas of voting with voting equipment.
- 7. No candidate, or individuals knowingly associated with the candidate, may carry electronic devices around campus specifically for students to vote on. This includes, but is not limited to: cell phones, laptops, and tablets.
- 8. All SGA elections shall be available and accessible to all Angelo State University students.
- 9. The Student Government Association President and Vice President shall be elected by a simple majority.
- 10. Student Senators shall be elected by a majority vote, with a minimum of five (5) votes to qualify.
- 11. Restrictions on election officials:
 - a. No member of the Election Commission shall influence the vote of another student in any way while serving on the Election Commission. Influencing the student vote is defined, but not limited to: Working for a specific candidate either officially or unofficially. Working for a candidate includes, but is not limited to: Writing or saying anything in any form (social media and or other digital media, print, over a broadcast etc.) that can influence a student's vote in favor or against any candidate.
- 12. At-large senator position may be filled if all senate positons are not filled during spring elections.

B. Run-off Election

- 1. In the event that general election results are protested and the Election Commissioner deems it necessary, then he/she shall call for a run-off election.
 - a. All run-off elections will be held on two consecutive days and will be completed within ten (10) days from the night the initial election results are posted, barring extenuating circumstances as determined by the Election Commissioner, such as protests.
 - b. The Commissioner shall hold a meeting with the candidates as soon as possible after a runoff has been called to explain any extra rules or requirements during the runoff.
 - c. All campaigning rules, election policies, regulations, and limitations shall apply to candidates during the run-off that applied during the regular election.
- 2. Run-off elections will only be held for presidential/vice presidential tickets. If there is a tie for a senatorial position and a run-off election occurs, the senatorial position resulting in a tie will be added to the run-off ballot. If there is not a run-off election, the current SGA Senate will vote on the senatorial seats resulting in a tie via secret ballot.

C. Senatorial Write-in Candidate:

- 1. There shall be no write-in candidates for Student Body President/Vice-President.
- 2. Senatorial write-in candidates shall be eligible only if they meet the qualifications for the position they seek and receive the required amount of votes necessary.
- 3. Write-in candidates for senatorial positions must receive a minimum of five (5) votes from eligible voters.
- 4. No senatorial write-in candidate shall be considered elected until certified through the Election Commissioner.
- 5. Elected senatorial write-in candidates must report to the SGA office to submit a current address, phone number, and campus I.D number. Failure to comply by the first class day of the fall semester with this clause automatically disqualifies the candidate.
- 6. Elected senatorial write-in candidates will be contacted by a member of the Election Commission and be notified of their election, as soon as possible.
- 7. All senatorial write-in candidates must comply with the Election Code.
- 8. No candidate who has been disqualified from an election shall be considered as a write-in for the same election.

E. Election Protests

1. Candidates have a duty to negotiate in good faith, and provide evidence, when disputes arise and must



attempt to reach a settlement consistent with this code and Election Commission decisions prior to filing a complaint.

- 2. Members of the commission are prohibited from filing complaints. Any other student may file a complaint with the commission.
- 3. Any person intending to contest the election must give the Election Commission, a sealed written statement of the grounds on which such contestant relies, which may include any and all supporting evidence to sustain such contest before election results are announced.
 - a. The complaint should be submitted in writing with the date, time, and description of the incident in question, as well as specifying the section of the Election Code in question.
 - b. When a complaint is filed, it should include the name of the person filing the complaint along with the name of the candidate against whom the complaint is filed. No anonymous complaints will be accepted.
- 4. The Election Commission may dismiss a complaint if:
 - a. It was not filed within 72 hours of the presenter/party/agent being made aware of the violation. No complaints may be filed after the candidates take office.
 - b. The Election commission lacks jurisdiction over the subject or party in the dispute.
 - c. The complaint fails to state a cause of action for which relief may be granted.
 - d. The complainant has not and likely will not suffer injury or damage.
- 5. All protests will be opened and read upon reception, by the Election Commission. Discussion of the protests shall remain between the Election Commission and the individuals involved until all protests have been filed.
- 6. The Election Commission shall consider all protests. The Election Commission shall, upon reviewing the contestant's written statement, research the grounds on which the contestant relies, and they shall formulate a written report to the Election Commissioner.
 - a. Any additional evidence or violations that are discovered in the process of research shall be included in the protest. The Election Commission shall consider violations by a candidate other than the defendant that are discovered in the process of research as separate protests.
 - b. If the Election Commissioner deems a hearing necessary it shall be held as soon as possible after the last day of the election. The Election Commissioner shall give at least one (1) days' notice of the date, time, and place of the hearing to all the parties
 - 1. Upon confirmation of a scheduled hearing by the Election Committee, the accused candidate will receive a copy of the complaint filed against him/her.
 - c. When notice of a hearing is issued, the Election Commission may issue a temporary restraining order halting all campaigning activities if it determines such action is necessary. Once issued, the restraining order will remain in effect until it is rescinded or the Election Commission announces a decision.
- 7. Procedures for Protest of Election Results:
 - a. For any hearing, the entire Election Commission must be in attendance, including the Election Commissioner. Election Commission members may be excused from the hearing at the discretion of the Election Commissioner. Three members of the Commission (including the Election Commissioner) must be present for quorum.
 - b. Each candidate shall be allowed ten (10) minutes to present his/her case. At this time, evidence may be presented to the Election Commission (photographs, written statements, etc.). The contesting candidate shall be allowed to speak first.
 - c. Each candidate or his /her representative shall be allowed one, five (5) minute rebuttal, with the defending party speaking last.
 - d. All questions and discussions by parties in the dispute shall be directed to the Election Commission.
 - e. The Election Commission will then, if necessary, question each candidate.
 - 1. There shall be no direct or cross-examination of any party or witness by complaining or responding parties.



- f. Each party will be allowed one, three (3) minute closing statement.
- g. The Election Commission shall meet in private to deliberate on the hearings and the written evidence provided, and render a decision. Within two (2) university working days thereafter, the Election Commission shall submit to the parties a written report including the grounds for the decision.
- h. Extenuating circumstances may cause the Election Commission to deviate from the defined time frames.
- 8. Resolution of the Complaint and Sanctions
 - a. The Election Commission reserves the right to use its discretion in the interpretation of the Election Code.
 - b. The Election Commission will take two votes. The first vote will determine if the accused is responsible or not responsible for the alleged violation. If a simple majority finds the accused responsible, the Election Commission will take a second vote to determine the sanction.
 - c. Election Commission shall:
 - 1. Determine that a violation of the Election Code did not occur; or
 - 2. Determine that a violation of the Election Code did occur but was not of a serious nature. In this event the Election Commission shall determine that a punishment or penalty is deemed unnecessary; or
 - 3. Determine that a violation of the Election Code did occur and was of a serious nature. In this event the Election Commission shall determine a punishment or penalty as deemed appropriate by them; or
 - 4. Determine that a violation of the Election Code did occur and was of the most serious nature. In this event, the candidate ticket in question shall then be disqualified.
 - d. If the disqualified candidate ticket received a majority of the votes cast then the next candidate ticket with the most votes shall be declared winner.
 - e. If a candidate who did not receive a majority of the votes is disqualified, then the election results shall stand.
 - f. Any disqualified candidate shall lose the right to run for office for twelve (12) months from the date of the offense.
- 9. If a protest is filed against the actual Election Commission then the process outlined in Article I Section D of the Election Code shall be followed. If the Election Commission member is found to have acted improperly the Election Commissioner shall assess the influence the member's actions could have had on election results by taking such factors into consideration as: When their action occurred in relation to when voting started and ended, the avenue by which the member acted with partiality (social media, printed material, speaking to student organizations etc.) and the range which it allowed in comparison to tangible amount of votes cast. If the protest has merit and the actions of the member could have tangibly swayed the election one way or the other, then there shall be a runoff between the top two contenders according to procedures established by Article V Section B of the Election Code.

Article VI - Enforcement and Penalties

A. Remedies and Sanctions

- 1. Any violation of the election code shall come under the jurisdiction of the Election Commission.
- 2. Penalties for said violations shall be determined by the Election Commission soon as possible after the violation.

Article VII - Provisions, Ratification, and Amendments



A. General Provisions

- 1. The Commission shall supervise activity and be available for assistance and ruling in any and all matters of confusion or conflict during any part of the election process.
- 2. In all elections governed by this code, no candidate shall personally, nor through a third party, deliberately ask for or require another student to disclose any of their personal information, including but not limited to: social security numbers, RamPort account usernames, and/or passwords. If solicitation of any personal information by any individual or organization campaigning for a candidate is discovered, said candidate will come before the Election Commission at a time and place to be decided on by the Election Commission for review and possible disqualification from the race.

B. Ratification and Amendment Procedure

- 1. This Election Code shall constitute valid operating procedures upon majority approval of the Angelo State University Student Senate and signature of the Angelo State University Student Body President.
- 2. Amendments to this code shall be made by a majority vote of the Student Senate.
- 3. Minor housekeeping work and corrections (spelling, punctuation, etc.) may be made to the code by the Judiciary and Rules Committee without legislative action as long as such an action does not change the meaning or intent of the Election Code.
- 4. The Judiciary and Rules Committee must notify the President of the Senate in an open letter to the entire Senate what changes they made to the Election Code with minor housekeeping.
